**INVITATION TO BID FOR THE SITE CLEARING & LOADING OF GARBAGE AT TRANSFER STATION IN THIS MUNICIPALITY (FOR 2<sup>ND</sup> QUARTER)**

The Municipality of Floridablanca through the Solid Waste Management Fund intends to apply the sum of **SIX HUNDRED SEVENTY FIVE THOUSAND ONE PESOS AND 45/100 (P 675,001.45)** being the Approved Budget for the Contract (ABC) to payments under the contract for the **SITE CLEARING & LOADING OF GARBAGE AT TRANSFER STATION IN THIS MUNICIPALITY (FOR 2<sup>ND</sup> QUARTER)**. Bids received in excess of the ABC shall be automatically rejected at bid opening.

The Municipality of Floridablanca now invites bids for the **SITE CLEARING & LOADING OF GARBAGE AT TRANSFER STATION IN THIS MUNICIPALITY (FOR 2<sup>ND</sup> QUARTER)**. Completion of works is required within Fifteen (15) Calendar Days. Bidders should have completed a contract similar to the project. The description of an eligible bidder is contained in the bidding documents, particularly, in Section II, Instruction to Bidders.

Bidding will be conducted through open competitive bidding procedures using non-discretionary pass/fail criterion as specified in the 2016 Revised Implementing Rules and Regulations (IRR) of Republic Act 9184 (RA 9184), otherwise known as the "Government Procurement Reform Act."

Bidding is restricted to Filipino citizens/sole proprietorships, cooperatives, and partnerships or organizations with at least seventy five percent (75%) interest or outstanding capital stock belonging to citizens of the Philippines.

Interested bidders may obtain further information from Municipality of Floridablanca and inspect the bidding documents at the address given below from 8:00 A.M. until 5:00 pm.

A complete set of bidding documents may be purchased by interested bidders from the address below starting on **February 14, 2019** and upon payment of a non-refundable fee for the bidding documents and it may also be downloaded free of charge from the website of the Philippine Government Electronic Procurement System (PhilGEPS) and the website of the Municipality of Floridablanca, provided that bidders shall pay the fee for the bidding documents not later than the submission of the bids.


The Municipality of Floridablanca will hold a Pre-bid conference on **February 22, 2019 at 2:00 p.m.**, which shall be open to all interested parties.


Bids must be delivered to the address below on or before **March 6, 2019 at 2:00 p.m.** at the BAC Secretariat, Municipality of Floridablanca at Floridablanca, Pampanga. All bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated at ITB Clause 18.

Bid opening shall be on **March 6, 2019 at 2:00 p.m.** at the BAC Secretariat, Municipality of Floridablanca at Floridablanca, Pampanga. Bids will be opened in the presence of the bidder's representatives who choose to attend at the address below. Late bids shall not be accepted.

The BAC Committee of the Municipality of Floridablanca reserves the right to reject any and all bids, declare a failure of bidding, or not award the contract any time prior to contract award in accordance with Section 41 of RA 9184 and its IRR, without thereby incurring any liability to the affected bidder or bidders.
